Although the 83-year-old Democrat is completing his fourth six-year term, the poll found a surprisingly large number of voters

## No tornado, but heavy winds, hail

LITTLE EGG HARBOR After rain, wind and lightning blasted through the area yesterday after-noon, authorities investi-gated whether a tornado touched down here.

Parts of the county were hit with a fast-moving thunderstorm, while other areas remained dry.

Heavy rain, hail, and strong winds pressed the township for about half an hour. The worst hit were the Mystic Islands, West

Tuckerton, and Par-kertown sections of the township. Lightning was reported throughout the area, striking trees and power lines, police said.

The National Weather Service responded to the area to survey the damage to determine if a tornado had formed, police said.

A weather service mete-orologist later reported that there had been no tornado, just wind damage.

The wind blew debris into the street. At least

Delays, lack of parking frustrate store's neighbors

TOMS RIVER - The lack of parking in front of a Normandy Beach con-venience store is not the only reason residents were up in arms at Wednesday night's Township Planning Board meeting.

Neighbors of the Check-Rite convenience store, lo-cated on Route 35 North and Normandy Way, went to the planning board meeting to object to plans to increase the retail space at the store, and build an apartment on top of the existing building. The building is owned by Avalon Distinctive Caters.

But they grew even more frustrated when the applicant's attorney Marc Ga-lella, with R.C. Shea and Associates, showed up without a promised set of revised architectural plans that would show adequate parking will be made available — which meant that the planning board hearing had to be delayed until Oc-

Galella said a computer glitch at the architectural

## Church: Dismiss sex abuse suit Men allege they were molested by reverend

Lawsuit cites 18 years of abuse



TOMS RIVER - Attorneys for St. Thomas Lu-theran Church in Brick, its school and its parent orga-nization will be in court today to ask a judge to dismiss a \$100 million lawsuit brought by 20 grown men who claim they were mo-lested as children by the onetime, now deceased church pastor in the 1960s, 1970s and 1980s.

The attorneys representing the church and its St. Thomas Christian Acad-Thomas Christian Academy, both on Salmon Street in Brick, a group of 192 Evangelical Lutheran churches known as the New Jersey Synod, and the Evangelical Lutheran Church in America will appropriate the Christian pear before Superior Court Judge Thomas E. O'Brien seeking dismissal of the lawsuit against them on grounds that the two-year statute of limitations to file a claim has long passed, and that state law immunizes charitable organiza-tions from such lawsuits.

Joining in their argu-ments for dismissal of the lawsuit will be attorneys for the estate of the Rev. Robert L. Slegel, who is al-leged to have molested the children, his widow, Cyn-thia Slegel, who was the onetime principal of the academy, and the Rev. John M. Elstad, a onetime associate pastor of the church under Slegel who rose to the position of pas-tor when Slegel resigned amid scandal in 1993. They are also named as defendants in the suit, originally filed in 2005 by Toms River attorney Robert R. Fuggi

An associate of Fuggi, Phillipsburg attorney Gre-gory Gianforcaro, will appear before O'Brien to argue that state law immunizes charitable organiza-tions against liability only in cases of negligence, not in instances of intentional

Gianforcaro also plans to argue that the law allows for suspension of the statute of limitations in in-stances of repressed mem-ory or until the victims of child sexual abuse realize that is what caused their present emotional prob-lems.

Following oral arguments, O'Brien will be called upon to decide whether the lawsuit can move forward.

The original lawsuit was Fuggi has amended it twice to include a total of 19 plaintiffs who claim they were abused by Slegel as children. There is a 20th man also being represented by Fuggi who also claims abuse by Slegel. Fuggi said he soon plans to amend the complaint again: to include that man as a defendant.

Fuggi said he is seeking \$5 million in damages for each of the men, bringing the total claims to \$100 mil-

Geoghan in Massachusetts The Archdiocese of Boston subsequently paid \$85 million to settle 552 claims of sexual abuse.

Last month, the Archdio-cese of Los Angeles announced it would pay \$660 million to settle claims brought by more than 500 people who said they were abused by Roman Catholic clergy members. If ap-proved, the settlement would be the largest by

any single diocese in a clergy sexual abuse scandal, the New York Times reported.

The scandal has not been limited to the Catholic Church. Christianity Today's Web site has reported settlements of jury awards in the \$30 million range in several states stemming from allegations that Lutheran ministers

sexually abused them. Fuggi has said he be-

lieves the suit he has filed is the first of its kind in Ocean County.

The men alleging abuse in the suit now range in age from 29 to 52, Fuggi said. Some were as young as 5 and as old as 15 when they claim to have endured the molestation, according to court papers.

Slegel is alleged to have committed the molestation
